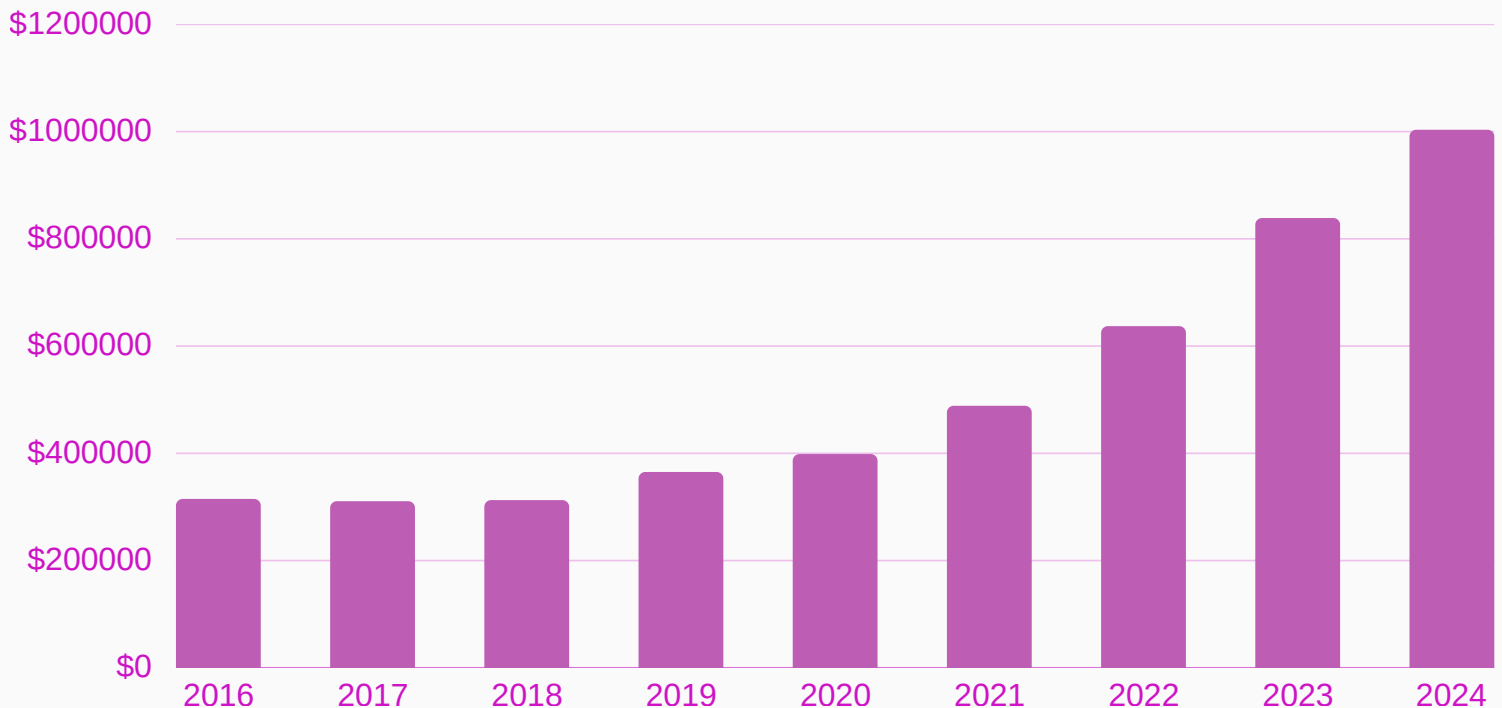

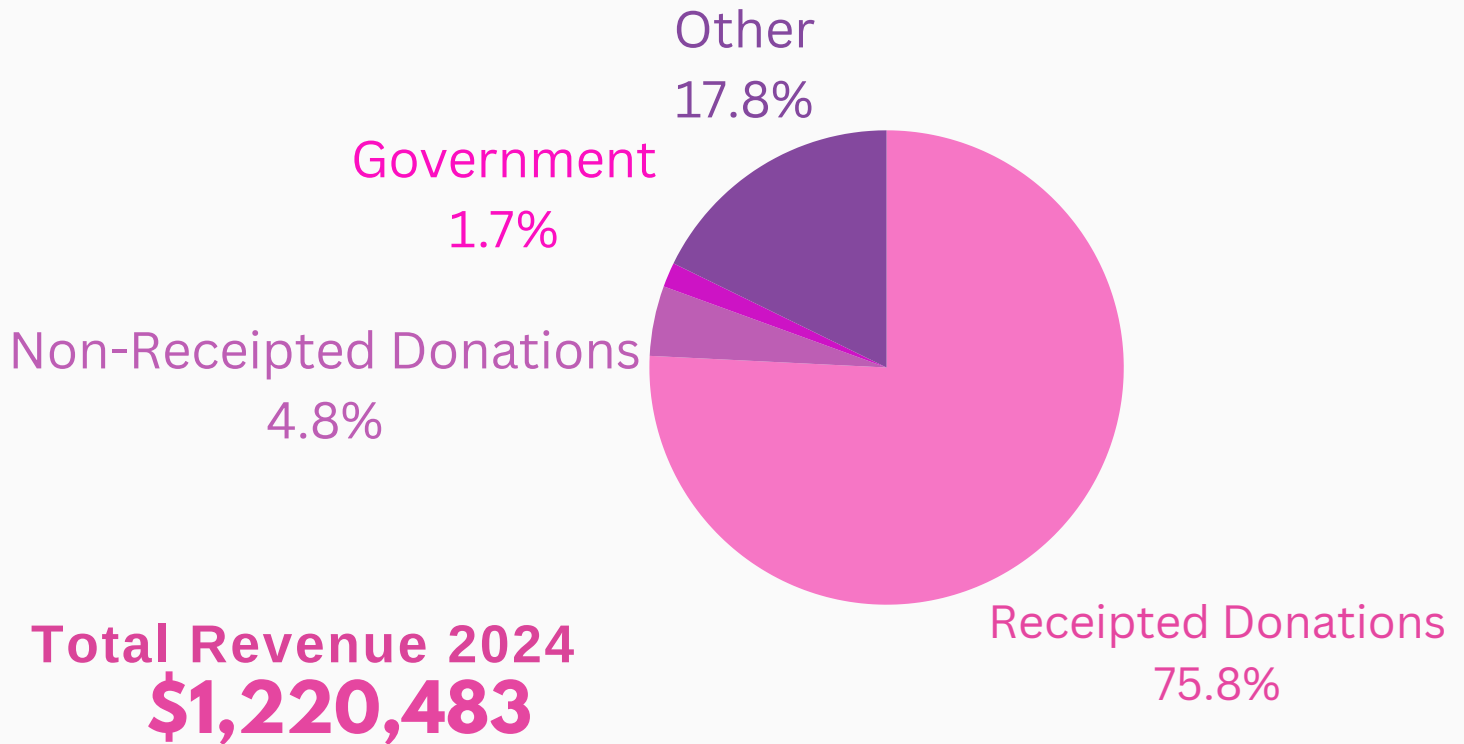

Financial Review Revenue



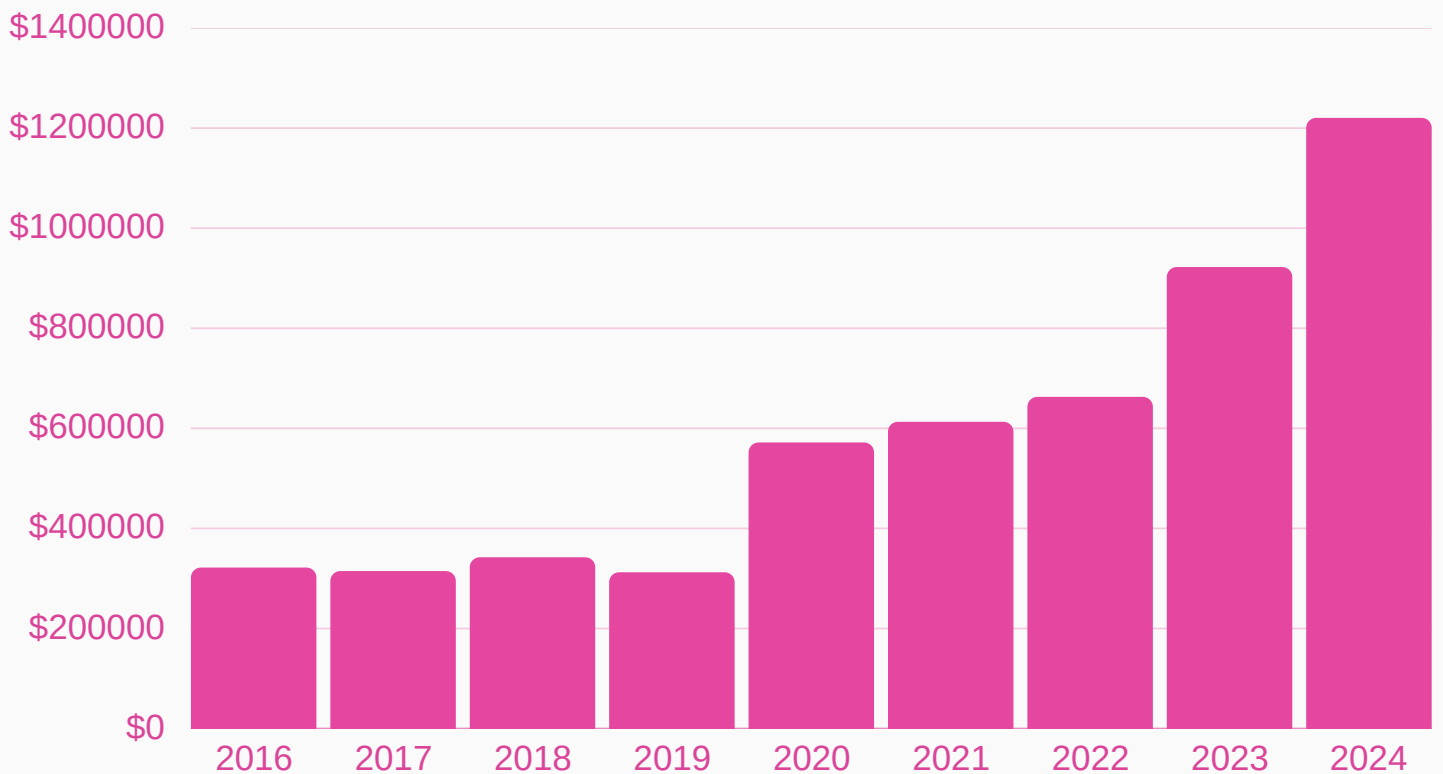
Total Revenue 2024
